THROUGH OUR VOLUNTEER CORPS OF 8,058 ADULTS, WE ARE ABLE TO SERVE GIRLS IN VIRTUALLY EVERY ZIP CODE IN THE 5 BOROUGHES. VOLUNTEERS CUMULATIVELY PARTICIPATED IN OVER 6,534 HOURS OF TRAINING TO ENHANCE THEIR KNOWLEDGE OF THE GIRL SCOUT PROGRAM AND ABILITY TO PROVIDE GIRLS WITH TRAVEL-RELATED AND CAMP EXPERIENCES.

IN 2014, WE PROVIDED 2,010 CAMPERS WITH SEASONAL WEEKEND OR OVERNIGHT CAMPING EXPERIENCES BETWEEN SEPTEMBER AND JUNE. DURING THE SUMMER, WE HAD 922 CAMPERS PARTICIPATE IN THEME-BASED SUMMER WEEKEND CAMPING EXPERIENCES, AS WELL AS 176 CAMPERS TO ATTEND SUMMER SPECIAL EVENTS.
