Photo Shoot Opportunity

DO YOU LOVE SELLING GIRL SCOUT COOKIES AND GETTING IN FRONT OF A CAMERA? THEN WE WANT TO HEAR FROM YOU!

What's happening?

This year 25-30 Girl Scouts from Long Island and Greater New York have the opportunity to be part of a photo shoot promoting Girl Scout cookies -- SWEET!

How will Girl Scouts of the USA use the pictures/videos?

These pictures/videos will become part of Girl Scouts' global library and might be featured in advertisements, flyers, videos, emails, and social media postings (among other things). That's right—you might become Girl Scout famous!

Who can participate?

To be eligible for this opportunity, you must:

- Be a current, registered Girl Scout. All Girl Scout levels are welcome.
- Be available to travel to a location in Nassau County, Long Island, on **Thursday, August 8th** or **Friday, August 9th** and be flexible about timing. Each girl selected will participate on only one of the two days listed above. We are still confirming shoot times, but we may start as early as 8:00 a.m. and might end as late as 7:00 p.m. We aim to limit total time on set for each girl to six hours. In the event of severe weather, our *backup* dates will be 8/15 & 8/16.
- Be comfortable posing in front of a camera.
- Have a parent/guardian willing to come along who will sign a photo/video release form in advance of the shoot. The release permits Girl Scouts of the USA to use the materials acquired during the shoot for future marketing purposes.
- Note: in addition to girls, we're looking for a few guardians who would like to be on camera as well. This is 100% optional for guardians. Please see application instructions for details.

Will there be any compensation?

Unfortunately, we are not able to provide any compensation, transportation or transportation reimbursement at this time. However, all girls will receive lunch and snacks.

What is the dress code?

If selected, we'll ask you to bring three unbranded plain-top options and two options for bottoms. Please avoid wearing branded clothing (anything with large logos or words), pinstripes or checkered patterns. We might also provide GSUSA wardrobe items to wear for the shoot, so be sure to include your clothing size in your application.

Get your submissions in ASAP.

We will notify all applicants by August 2nd to let them know if they have been selected or not. We hope you can join us for this unforgettable Girl Scout adventure, which you're sure to learn a ton from. Thank you so much for helping us show the world the amazing things that girls do through the Girl Scout Cookie Program!

To participate, have your parent/guardian **FILL OUT THIS FORM.** Please send us:

1. A picture of yourself
2. Your full name, age & council
3. Your Girl Scout level
4. Your clothing size
5. Your guardian's full name, email and phone
6. OPTIONAL: *if* your guardian is also interested in being on-camera, then they should send in a *separate* application that includes a photo, top size, guardian's name and child's name.
